# UNDERGROUND STORAGE TANK Certification Course

## Course Overview

This course covers the proper installation, removal and repair of underground storage tanks and piping according to Federal and State Codes. It includes contractor responsibilities, OSHA Safety and Right-to-Know regulations, projects management parameters, and critical junctures. It also covers corrosion control principles, leak detection methods, site assessment procedures and spill clean-up procedures

## Purpose and Scope

This course was developed by Riverland Community College in cooperation with the Minnesota Pollution Control Agency and is intended to train and certify individuals to install, remove or repair underground storage tanks. This course meets the requirements of Minnesota Rule Chapter 7105. A final written exam will be given after attending the entire course. Individuals scoring 75 percent or better may make application to the Minnesota Pollution Control Agency to be licensed as Certified Supervisors.

*MPCA requires additional experience and fees for this certification*
