Animal Feedlot Rules chapter 7020

Minn. R. 7020.0405, subpart 4, requires the new owner of an animal feedlot or manure storage area to complete and submit a change of ownership form to the MPCA or delegated county feedlot pollution control officer. This form must be completed and submitted prior to a change in ownership or control of an animal feedlot or manure storage area not covered by a National Pollutant Discharge Elimination System (NPDES) permit. **Note:** Changes at the animal feedlot or manure storage facility other than a change in ownership or control of the facility may require completion and submittal of a permit application.
