# **Selling Fluorescent Lamps**

# Guidance for Minnesota retailers, commercial sellers, and contractors

Fluorescent lamps include all sizes and shapes of lamps that produce light by electrifying mercury vapor in a glass tube. They are sold in straight tubes, circles, coils, and other shapes. Compact fluorescent lamps (CFLs) are a type of fluorescent lamp.

All fluorescent lamps, including CFLs and tubes with so-called 'green tips', contain mercury and must be recycled after use in Minnesota. They may not be broken or placed into the normal trash.

# Are you a retailer, commercial seller, or contractor of fluorescent lamps?

You are a retailer if you sell fluorescent lamps to citizens or incidentally to businesses for their use.

You are a *commercial seller* if you sell fluorescent lamps specifically to industrial, commercial, office, or multiunit residential building owners or managers, or to lighting installation or replacement contractors.

You are a *contractor* if you replace or remove fluorescent lamps for the owners or managers of industrial, commercial, office, or multiunit residential building or outdoor lighting systems.

## Retailer requirements

Post either the sign attached to this fact sheet or your own notice.

If you post your own notice, it may be any size, color, or shape, but must contain the following text in at least 36-point type:

"Fluorescent bulbs save energy and reduce environmental pollution. Note: Fluorescent bulbs contain a small amount of mercury and must be recycled at the end of their use. Contact your county or utility for recycling options."

You may add promotional or other language to the notice. You may also, but are not required to, add the location or contact information for a local collection site if you do not collect spent lamps yourself.

You are not required to accept spent fluorescent lamps back from customers or the public for recycling, however if you do, manage them as a universal waste. See MPCA fact sheet #w-hw4-62, Managing Universal Wastes, at http://www.pca.state.mn.us/publications/w-hw4-62.pdf.

## **Commercial seller requirements**

Include a statement on all invoices for lamps or in a separate document provided to the purchaser. The statement must declare that the fluorescent lamps you are selling contain mercury, a hazardous substance regulated by federal or state law, and that the lamps may not be placed into solid waste.

You are not required to accept spent fluorescent lamps back from your customers for recycling, however if you do, manage them as a universal waste. See MPCA fact sheet #w-hw4-62, Managing Universal Wastes, at http://www.pca.state.mn.us/publications/w-hw4-62.pdf.

### **Contractor requirements**

Notify in writing the property or equipment owner or manager who hired you that the lamps being removed contain mercury and describe your plan for how the lamps will be recycled.

You are jointly responsible with the person who hired you to properly collect and recycle the removed fluorescent lamps. Manage removed fluorescent lamps as a universal waste. 
