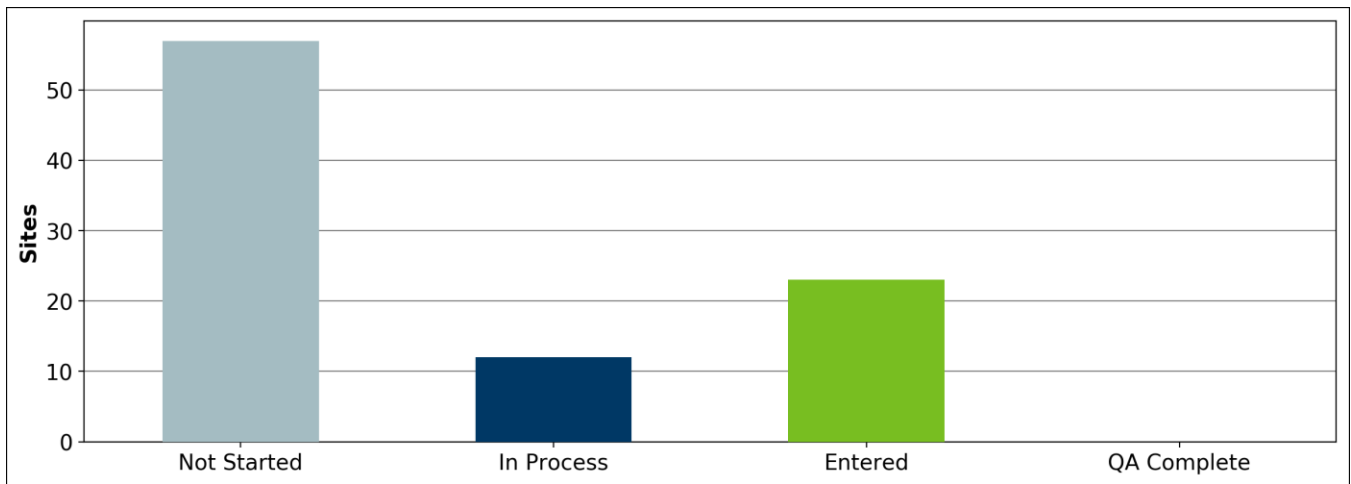

Total Number of Wells in EQulS

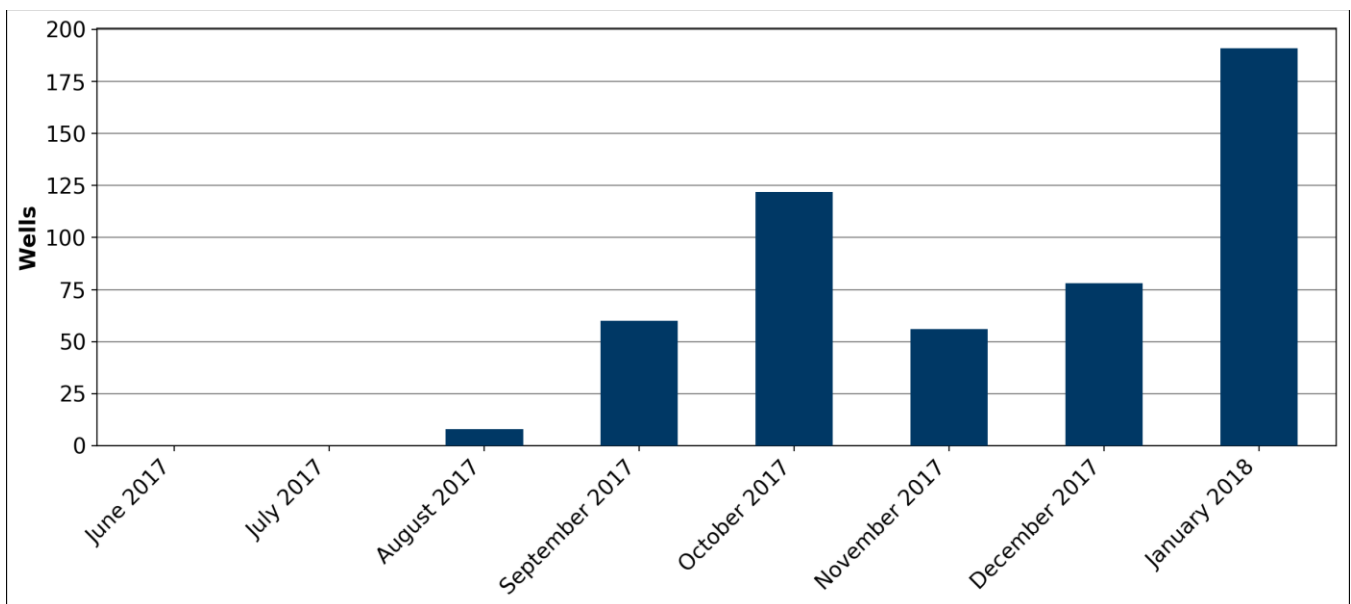
