

Quick guide - Nonmetallic mineral processing air emission inventory report

General permittees cover letter

As the owner or operator of a permitted air quality facility, you are required to submit an emission inventory report by **April 1, 2026**. If your facility does not submit an air emission inventory report on time, enforcement action may be taken, and your next annual air fee will include an additional fee.

What do I need to do?

1. Complete the enclosed air emission inventory report for your nonmetallic mineral processing permitted facility.
2. If your facility operated multiple sites during the year, copy the report and complete an air emission report for each site.
3. Sign and date the report(s).
4. Make a copy for your records.
5. Return the original report(s), postmarked no later than April 1, 2026, to:

What if there have been changes at my facility?

You must notify the Minnesota Pollution Control Agency (MPCA) if any of the following have changed:

- Facility name
- Ownership or control of the facility
- Owner or operator's name
- Facility location

Registration permit holders may use MPCA e-Services for air administrative changes.

If your facility has seen a change in general contact information (i.e. permit or billing name, email, or phone number), please email air quality program staff contact to notify the MPCA of these changes. What if my facility permanently closed?

Submit a Notice of Permit Termination request using MPCA's e-Services at <https://rsp.pca.state.mn.us/>.

What if my facility relocated?

If the facility is a portable plant and has relocated to a location authorized by the existing permit, submit Form NM-RE, Location Notification at <https://www.pca.state.mn.us/business-with-us/air-permit-application-forms>.

You must notify the MPCA each time the facility changes location.
