MPCA Brownfield Program 2024 Annual Report

Introduction

A "brownfield" is any property that is abandoned or underused due to the known or likely presence of contamination. Brownfields are located in cities and towns all across Minnesota. Whether it's a deserted railroad depot, a closed factory, a former drycleaner, or an abandoned gas station, brownfields offer both a challenge and an opportunity for local communities and developers. The Minnesota Pollution Control Agency's (MPCA) Brownfield Program was created to help overcome the environmental and legal barriers that prevent the redevelopment of these properties. The MPCA Brownfield Program is a fee-for-service program that provides technical assistance and various assurance letters to promote the investigation, cleanup, and redevelopment of property that is contaminated with petroleum and/or hazardous substances. The assurance letters provide liability protection for eligible parties and environmental closure for identified contamination. Customers include property owners, prospective purchasers, developers, development agencies, lending institutions, nonprofit organizations, and local units of government. Information about the types of letters offered by the Brownfield Program can be found on the Brownfield Program Services guidance document.

The MPCA Brownfield Program consists of two integrated technical programs: the Petroleum Brownfield Program, which handles petroleum contamination under the Petroleum Tank Release Cleanup Act (Minn. Stat. § 115C); and the Voluntary Investigation and Cleanup (VIC) Program, which handles hazardous substance contamination under Minnesota's Environmental Response and Liability Act (Minn. Stat. § 115B). The Brownfield Program also includes a Community

Outreach & Engagement Unit, which supports the work of the technical units by providing education and other non-technical assistance.




StoryMap update



2024 new brownfield applications statewide




2024 new brownfield applications by subprogram






2024 brownfield applications in Greater Minnesota














Annual brownfield site applications

Brownfield guidance update

In 2024, the MPCA's Brownfield Program created or updated several guidance documents to help program applicants and their representatives understand the options and requirements for Brownfield Program services.

Brownfield Program Services describes the various assurance letters offered by the Brownfield Program for technical assistance, liability protection, and environmental closure. The document provides helpful tips regarding eligibility and technical requirements for each letter. Having a clear understanding of the technical requirements for certain assurance letters can help environmental consultants design a scope of work that provides the required data to support the request for assurances.



Phase I ESA Report for Brownfield Program Enrollment describes the importance of environmental due diligence for parties planning a property transaction and lists key information that is useful to Brownfield Program staff during site review. Providing this information at the time of enrollment allows Brownfield Program staff to review site information more efficiently and can lead to a quicker decision about next steps.

Brownfield Program Response Action Plans provides an overview of *risk exposure pathways* to be evaluated for a brownfield redevelopment project, the *risk-based screening values* for each relevant pathway, with links to supporting material, and other helpful information to consider during preparation of a response action plan (RAP). Appendix A is a list of topics commonly addressed in a RAP and can be used as a checklist to ensure the RAP is complete and meets Brownfield Program requirements.



Best management practices for development on or near former dumps describes the potential hazards associated with development projects on or near former dumps and the necessary steps for investigation, waste characterization, and possible response actions. Early communication with the MPCA during the planning process is key to determine the feasibility of the redevelopment project, if Brownfield Program assurances are needed.



<u>Remediation Division Methane Guidance</u> provides general information about methane in the environment and guidance on investigating, monitoring, and responding to methane at remediation sites.



Remediation Division Institutional Control Guidance describes the tools that can be used to control land use or manage potential future risk at a site with residual contamination. The appendices are of particular interest for environmental professionals working on brownfield sites.

New "Brownfields in your community" webpage

This year the MPCA created a new webpage for the general public called "Brownfields in Your Community." The Brownfields Program has long had technical resources for experienced brownfield developers, lenders, attorneys, and other professionals well acquainted with the brownfield process. However, residents, small communities, first-time developers, and prospective purchasers couldn't easily find basic information. The new webpage is full of information for buyers and sellers of property, including grants for brownfield investigation, a StoryMap of brownfield success stories, and other helpful resources.

Community Outreach and Engagement Unit

The MPCA's Brownfield Community Outreach and Engagement (CO&E) Unit was created in 2023 to support and enhance the work of the Brownfield Program by expanding and deepening outreach to local units of government, tribal nations, underserved communities, and property owners and professionals involved in brownfield redevelopment and real estate transactions. The unit consists of a supervisor and two planners, one of whom is based in Duluth. The CO&E Unit collaborates regularly with local governments and community groups around the state, often in partnership with Kansas State University's Technical Assistance to Brownfields program (KSUTAB), the nonprofit Minnesota Brownfields, and MPCA's Tribal Liaison.

Site and community-level support

CO&E Unit staff help small business owners, first-time developers, small communities, and others who are new to brownfield redevelopment with information on how to navigate the site investigation and remediation process. They also connect these entities with potential funding sources. In addition to the MPCA's Targeted Brownfield Assessment grant program, small entrepreneurs may be directed to the MPCA's Small Business Environmental Improvement Loans or other grant sources.

The CO&E Unit worked with several municipalities across the state this year to support brownfield reuse planning, including the cities of Duluth, Sebeka, and Rushford. CO&E

Unit staff helped the city of Hackensack navigate the MPCA's asbestos program. Many redevelopment projects were supported by the CO&E Unit in 2024, including Little Africa Plaza, an African grocery store and business incubator in Saint Paul, and the Duluth youth-focused nonprofit Welch Center, which discovered the MPCA's Targeted Brownfield Assessment grant program through an April workshop in Lincoln Park cohosted by the CO&E Unit, the city of Duluth, and KSUTAB.

Tribal assistance

A high priority for the Brownfield Program is helping Tribal Nations in Minnesota access brownfield resources. Each of the Tribal Nations faces unique circumstances in addressing brownfields on their traditional lands, requiring a personalized approach. In 2024, the CO&E Unit reached out to each of the 11 Tribal Nations in Minnesota to introduce our team and offer an in-person meeting in their community. Individualized engagement, in addition to connections made through workshops and official Tribal consultations, helped us build new relationships with the Mille Lacs Band of Ojibwe, the Lower Sioux Indian Community, and the Red Lake Nation. We have collaborated with Brownfield staff from these Tribal Nations to create brownfield inventories, support current and future community engagement efforts, and identify sources of funding to support ongoing brownfield assessments and reuse.

Brownfields education and tools

The CO&E Unit organizes brownfields education events to explain the significance of brownfields within communities and how to successfully investigate, remediate, and redevelop contaminated sites. The unit often coordinates these events at the request of a community or neighborhood but has also conducted events with a statewide audience. In 2024, these workshops included: a training for emerging developers; a statewide webinar and workshop series for local governments tackling how to pay for brownfield site investigation, cleanup, and redevelopment; and a brownfield redevelopment workshop series co-hosted with the city of Duluth for small landlords, property owners, and community residents.

Throughout the year, the CO&E Unit created tools ranging from communicating the basics of brownfields to the public to accessing various brownfield funding sources. A few examples include:

- a list of site investigation and redevelopment funding options available in Minnesota, including local, regional, state, and federal resources
- a brownfield inventory template that can be customized for neighborhood or community use
- translations of brownfield fact sheets into five of the most commonly spoken languages in Minnesota
- a new MPCA "Brownfields in Your Community" webpage geared towards the general public

Community events

Tabling at community events allows us to connect with residents, answer their questions about brownfields, and provide resources in multiple languages. The goal at these events is to demonstrate how brownfield redevelopment directly benefits communities and to be a visible state agency ambassador who can serve as a future point of contact for brownfield-related inquiries. State Fair Eco Experience

New in 2024, the Brownfields Program hosted a Brownfields in Your Neighborhood exhibit at the MPCA's **State Fair Eco Experience** (photos below). We connected with hundreds of visitors to answer questions about the basics of brownfields and used an interactive flipbook to highlight successful and well-known brownfield redevelopment projects from around Minnesota. We also engaged all ages in a hands-on brownfield "dig" activity to demonstrate how contamination occurs and how to clean it up and then reuse the land.







Cost recovery

Minnesota state law requires parties requesting assistance from the MPCA's Brownfield Program to pay the agency for the cost of providing assistance. The current fee is \$150/hour. Brownfield Program staff track the time they spend doing site work, including the time to review reports and correspondence, provide guidance and technical assistance, and issue requested assurance letters.

As shown in the table below, the Voluntary Investigation and Cleanup (VIC) Program invoiced \$622,575 in 2024 and the Petroleum Brownfields Program (PBP) invoiced \$343,238. The average cost recovery rate for the Brownfield Program for the previous four calendar years (2020 through 2023) is 99.6%. The cost recovery rate is always temporarily low for the current reporting year (2024), as payments are still being received for invoices sent late in the reporting period. As additional payments are received for site work completed in 2024, the collection rate will increase to be consistent with that of previous years.




MPCA funding for brownfield projects

The MPCA has two grants from the U.S. Environmental Protection Agency (EPA) to promote brownfield redevelopment in Minnesota, as described below. Grant funds can be used to pay for Phase I and Phase II Environmental Site Assessments, hazardous building material surveys, preparation of cleanup plans, community engagement for reuse planning, and Brownfield Program fees for MPCA review and oversight. Assessment work is completed by MPCA contractors at no cost to grant recipients. Applications are accepted on a rolling basis. Many MPCA grant sites also receive grant funding from partners such as Minnesota Department of Employment and Economic Development (DEED), Metropolitan Council, and counties.

Community-wide Assessment Grant for States and Tribes (104k grant)

The MPCA's Brownfield Program applied for competitive grant funds made possible by the Infrastructure Investment and Jobs Act (aka Bipartisan Infrastructure Law) and was awarded a \$2 million Community-wide Assessment Grant by the EPA in 2022. The grant funds are being used at brownfield sites in areas of concern for environmental justice for projects that have community support, avoid gentrification of the neighborhood, and support first-time developers. The grant has a performance period of up to five years, although at the end of 2024, approximately 86% of this grant has been allocated. In 2024, the Brownfield Program funded environmental investigations at 25 sites in our four target areas (West Broadway Avenue Corridor, University Avenue Corridor, Lake Street Corridor, and the City of Cass Lake) and in other areas of the state. To date, the MPCA has provided 104k grants to a total of 38 sites to support brownfield redevelopment in environmental justice areas.

Targeted Brownfield Assessment program (Section 128a grant)

The MPCA's Targeted Brownfield Assessment (TBA) Program is funded by an annual grant from the EPA, made available through federal brownfields legislation. In 2024, the MPCA's TBA grant program provided approximately \$784,867 dollars to assist with environmental assessments at brownfield sites in Minnesota. The source of this funding comes from the EPA through Section 128a funds, a pot of money that was notably larger in 2023 and 2024 due to additional funds made available by the Bipartisan Infrastructure Law.

The MPCA favors applications that promote brownfield redevelopment projects located in small communities in greater Minnesota or environmental justice areas, or those that support nonprofit organizations, first-time developers, or create community greenspace. Since the program's inception in 2003, the MPCA's TBA grant program has paid for environmental investigations at 99 sites.



Environmental justice areas and MPCA grant sites

Environmental justice areas are defined by census tracts that meet one or more of the following criteria: at least 35% of people reported income less than 200% of the federal poverty level; 40% or more people of color; federally recognized Tribal areas; and at least 40% of people have limited English proficiency. Data comes from the U.S. Census Bureau. For more information about environmental justice areas in Minnesota and interactive maps, see the MPCA's Environmental Justice webpage. Note that previous environmental justice areas (prior to 2024) included a margin of error that resulted in a larger area. Current environmental justice areas only include those where the calculated value meets one or more environmental justice criteria and do not include a margin of error.



Partnerships

A successful brownfield redevelopment project depends on many partners working together to navigate the environmental, legal, and financial challenges that arise when transforming a blighted property into a community resource. The MPCA Brownfield Program strives to develop strong partnerships with program applicants and organizations that support brownfield redevelopment work in Minnesota. Key partnerships include Minnesota Brownfields, a 501(c) (3) nonprofit organization which is dedicated to promoting the efficient cleanup and reuse of contaminated land through education and research. MPCA staff are frequent speakers at Minnesota Brownfield forums, where topics are often chosen to coincide with current MPCA initiatives. Minnesota Brownfields also serves as an effective and efficient way for the MPCA's Brownfield Program to seek feedback when developing new guidance on topics of importance to Minnesota's brownfield community. The MPCA Brownfield Program partners with the Minnesota Department of Employment and Economic Development (DEED) and the Metropolitan Council by providing technical support and review of applications submitted to their contamination investigation and cleanup grant programs. On redevelopment projects where the community has questions about risk to public health, the MPCA's Brownfield Program works with the Minnesota Department of Health to resolve concerns. The MPCA's Brownfield Program coordinates with the Minnesota Department of **Agriculture** if a brownfield redevelopment site also contains a release of agricultural chemicals. The **U.S. Environmental Protection Agency** provides valuable financial support to MPCA's Brownfield Program through federal grants that help pay for program operational expenses and investigation grants administered by the MPCA.
