Dear Mr. Deeney:

The Minnesota Pollution Control Agency (MPCA) completed its review of the Vapor Intrusion Pathway Investigation and Feasibility Study Work Plan. The work plan dated August 2014, and the Revised Figure 18, submitted September 17, were prepared and submitted on behalf of General Mills by Barr Engineering Company.

The work plan is approved with the following additional required actions:

1. Install and sample two additional glacial drift aquifer monitoring wells:
  - One near the intersection of 13<sup>th</sup> Avenue SE and 8<sup>th</sup> Street SE
  - One near the intersection of 17<sup>th</sup> Avenue SE and Elm Street SE
2. Expand the soil-gas monitoring network to surround the area of vapor concern southwest of the vapor mitigation area established in the site documents. Work in this area is ongoing. The MPCA will direct the specific location of monitoring points once the impact area is fully defined.

The work plan is a requirement of the March 2014 Response Action Plan Modification #1 (RAP) document. The RAP outlines the required elements of the Work Plan which include plans for:

- Additional soil, soil gas and groundwater testing to define the area of contamination.
- Identifying and evaluating potential remediation technologies for cleaning up the remaining contamination that is creating the vapor intrusion risk.
- Schedule for completing these activities.
