This causes inefficient combustion which results in excess pollution, which has been an ongoing problem with the coal-burning boilers. The agreement requires the facility to submit monthly reports to the MPCA on deviations from permitted emissions and to take steps to use more natural gas in the facility and reduce its dependence on coal.	\$26,947
5/18/2021	STIP	<u>Lakehead Trucking Inc (Duluth, MN)</u>	Duluth	Industrial Stormwater - MPCA inspections showed Lakehead was "daylighting" floor-drain waste — allowing it to flow into soils rather than into a proper disposal system. Used oil and other automotive fluids from vehicle washing and maintenance contaminated the soil around the building. The company failed to stop the discharges, and clean up the contamination. The company also improperly stored used oil and oil filters, and had begun sand and gravel mining operations at two sites without obtaining required industrial and construction stormwater permits.	\$23,000
