### SCOPE OF ADDENDUM

The RFP is revised as follows with ~~strike through~~ for deletions and underlining for insertions:

#### Revision 1

In the RFP, page 1 is amended as follows:

Proposals are requested from eligible applicants for dry cleaner cost share awards. This RFP will remain open and applications will be accepted on a rolling basis until all dedicated funds have been dispersed or until **4:00 pm Central Time** on ~~Wednesday, January 31, 2024~~ Monday, April 1, 2024, whichever occurs first.

Projects must be completed by ~~April 30, 2024~~ June 30, 2024, to be eligible for reimbursement.

#### Revision 2

In the RFP, page 1, "Funding" is amended as follows:

### 2. Funding

---

\$335,000 in funding is available. Awards to eligible applicants will be made on a first come, first serve basis until all funds have been awarded or until ~~January 31, 2024~~ April 1, 2024, whichever occurs first. Awardees have until ~~April 30, 2024~~ June 30, 2024 to complete their projects and utilize funding.

#### Revision 3

In the RFP, page 2, "Application submission instructions" is amended as follows:

### 5. Application submission instructions

---

All applicants must submit the Rolling Application Form. Applications must be received electronically by the MPCA **no later than 4:00 pm Central Time** on ~~January 31, 2024~~ April 1, 2024. The email properties header will reflect the date and time submissions are received. Application submissions received after the deadline will be ineligible. Email applications to [grants.pca@state.mn.us](mailto:grants.pca@state.mn.us) with the subject line: **"Dry Cleaner Cost Share Rolling Application"** The MPCA is not responsible for any errors or delays caused by technology-related issues.

MPCA may choose not to award all funding. This RFP does not obligate the State to award a grant, and the State reserves the right to cancel this solicitation if it is considered to be in its best interest.

## Revision 4

In the Application, page 1 is amended as follows:
