### SCOPE OF ADDENDUM

#### Revision 1

In the RFP, page 1 is amended as follows:

Proposals are requested from eligible applicants for Per- and polyfluoroalkyl substances (PFAS) Source Identification and Reduction Grants. This Request for Proposals (RFP) will remain open, and applications will be accepted on a rolling basis until all dedicated funds have been dispersed or until **4:00 pm Central Time on ~~Wednesday, April 2, 2025~~ Thursday, July 31, 2025**, whichever comes first.

#### Revision 2

In the RFP, page 1, "Funding" is amended as follows:

Approximately \$2,000,000 in funding is available. This RFP will remain open, and applications will be accepted on a rolling, first come, first serve basis until all dedicated funds have been awarded or **4:00 pm Central Time on ~~Wednesday, April 2, 2025~~ Thursday, July 31, 2025**, whichever occurs first.

#### Revision 3

In the RFP, page 4, "Application submission instructions" is amended as follows:

All applicants must submit the Rolling Application Form. Applications must be received electronically by the MPCA **no later than 4:00 pm Central Time on ~~Wednesday, April 2, 2025~~ Thursday, July 31, 2025**. The email properties header will reflect the date and time submissions are received. Application submissions received after the deadline will be ineligible.
