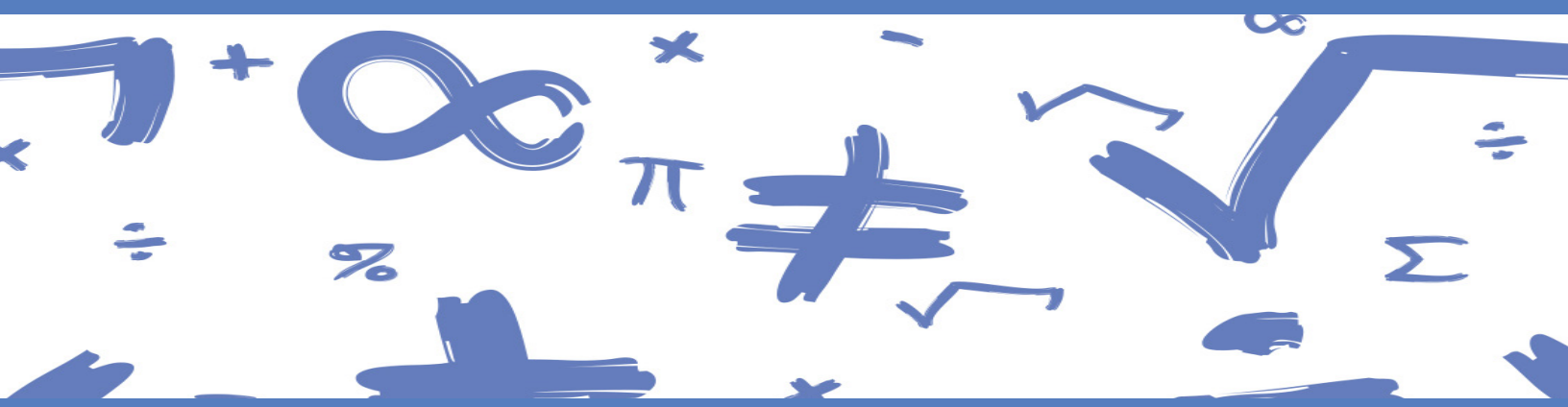


# Wastewater Class D Math Webinar

## Description

Math Webinars are offered as a refresher to help wastewater operators prepare for solving math problems associated with Class D job descriptions. This webinar will cover essential math skills including how to convert units of measure and the order of operations. The webinar provides opportunities to practice solving common math problems and attendees will work through solving math problems step-by-step with guidance from instructors. Math problems include pond discharge math, pump calibration, geometric mean, converting units, using common formulas, percent removal, loading, detention time, and calculating volume, area, velocity, and perimeter. This webinar is intended to refresh basic knowledge related to need-to-know content for Class D operators.
