

Architectural paint for Very Small Quantity Generators

What is architectural paint?

Architectural paint in Minnesota means interior and exterior architectural coating products in original containers of five gallons or less, including both latex and oil or solvent-based paint. The Minnesota Pollution Control Agency (MPCA) and the Metropolitan Counties of Anoka, Carver, Dakota, Hennepin, Ramsey, Scott, and Washington (Metro Counties) regulate the management of waste architectural paint.

Field and lawn paint	Caulk, epoxy, glue, and adhesive
Lacquer and shellac	Deck cleaner
Latex paint intended for walls, ceilings, floors, and trim	Equipment and industrial coatings
Metal coating, including rust preventative	Roof patch and repair
Oil-base paint & stain intended for walls, ceilings, floors, and trim	Tar and bitumen-based product
Primer, sealer, and undercoat	Thinner, stripper, and solvent
Varnish and urethane	Traffic and road marking paint
Water-proofer, sealer, and water repeller	Wood preservative containing pesticide

Free architectural paint collection for Very Small Quantity Generators

Any *Very Small Quantity Generator (VSQG)* in Minnesota may dispose of their waste architectural paint for free at a Licensed Paint Collection Site (LPCS), including many paint and hardware stores. The architectural paint collection program in Minnesota is operated by an organization called PaintCare™.

Your site must:

1. **Be a VSQG.** Most oil and solvent-based coatings are hazardous wastes when discarded; most latex and water-based coatings are non-hazardous. For help identifying hazardous wastes, see MPCA fact sheet #w-hw1-01, Evaluate waste, at: <https://www.pca.state.mn.us/sites/default/files/w-hw1-01.pdf>
A site that is a VSQG generates 220 pounds or less (about 22 gallons of oil-based paint) per month of all hazardous wastes. A VSQG may, however, accumulate up to 2200 pounds (about 220 gallons) of hazardous waste and dispose of it at one time and still be a VSQG. 2. **Obtain an HWID.** Ensure your site has a *Hazardous Waste Identification Number (HWID)*, also known as an *EPA ID#*) before you take any hazardous waste architectural paint to an LPCS. If your site does not have an HWID, follow the instructions in MPCA fact sheet #w-hw5-12, Notification of Regulated Waste Activity, at: <https://www.pca.state.mn.us/sites/default/files/w-hw5-12.pdf>
3. **Obtain a receipt and keep disposal records.** You must obtain a receipt for and keep records of hazardous waste architectural paints you take to an LPCS. See MPCA fact sheet #w-hw1-10, Keep hazardous waste records, at: <https://www.pca.state.mn.us/sites/default/files/w-hw1-10.pdf>

How must hazardous waste architectural paint be accumulated?

Keep hazardous waste architectural paint in closed, original, labeled containers. Make sure you also meet all other applicable hazardous waste accumulation requirements. See MPCA fact sheet #w-hw1-05, Accumulate hazardous waste, at: <https://www.pca.state.mn.us/sites/default/files/w-hw1-05.pdf>

What about wastes that are not architectural paints?

Hazardous wastes that are not architectural paints, such as art and craft paint, automotive paint, and thinners and solvents, must be managed as fully regulated hazardous wastes.
