CAA updates

Presented by Bridget Anderson and Kris Coperine, CAA staff

Kris Coperine is the MN program manager for CAA (based in MN).

Producer registrations continuing, driven by California's registration process. There are overlapping producers across states, but Minnesota still has unique producers to recruit into the program. A MN addendum is still in progress.

Agency updates

Open Advisory Board positions: compost facility or association position open until 11/3. Retailer position open until 10/27.

Procedure Updates

Reminder for advisory board members to email agency staff directly about board meeting needs in the future and avoid replying to all board members with responses.

Examples of letters and reports from other packaging EPR advisory boards to their respective regulatory parties.

A committee process is being used to review the draft Preliminary Assessment. Members have been selected and meetings are established for this group. They will help guide the development of comments by the board and compile feedback at the December 3rd meeting followed by consolidating that feedback into a document that will be reviewed and approved at a December 17th meeting and then submitted to the agency.

Board concerns about not having an opportunity to review public comments on the draft report before finalizing their comments. The discussion resulted in agreeing to review the process for the Needs Assessment and reserving the right to submit additional comments as needed after reviewing the public comments.

Covered Materials Categories List

Presented by Mallory Anderson, MPCA staff

Establishing a continued place in meetings to discuss the covered materials category list. Shredded paper was brought up as a concern to address. This list will continue to evolve as we receive input, collect data and feedback for the needs assessment, and beyond.

Update on Preliminary Assessment

Presented by Mallory Anderson, MPCA staff

Mallory presented an overview of the status of the draft Preliminary Assessment with Eunomia. Some items are a challenge withing the short report drafting period like collecting data on hauling contracts and costs.

Design for Refill, Reuse, Recycling, and Composting

General Mill's Experience

Presented by Taylor Loeber, General Mills

Shared the timeline and process for developing packaging. Shared that it is 6-10 years to redesign the packaging from development, lab scale, testing, consumer testing, and products being made. She noted that it can be Packaging EPR Advisory Board Meeting Packet • November 19, 2025

several years before a product gets to consumer testing – at which point it must go back to the beginning if feedback is too negative.

There are significant complexities to the cost of this work and the cost of EPR for packaging.

Plastic recycling & the APR design guideline

Presented by Kate Bailey, The Association of Plastic Recyclers (APR)

APR is an important communicator between recyclers and producers. APR buys bails from MRFs, processed and reused in end markets. Studies are showing that recycling can still increase by 400% overall/nationally. Recent shifts in the last 10 years have caused almost all recycling to be done domestically (93% of recycled products come from domestic sources). Recycling used to be handled more oversees by other countries that we sent our materials to. APR has developed important design considerations that are key for moving forward with advancements to plastics recycling and EPR for packaging can play an important role in advancing better design and recycling of plastics.

Public comment

Kimberly Davis, Consultant Slea Head Consulting asked: How are you dealing with compostable content in recycling stream?

Response: Compostables are a challenge when they come to a MRF facility. Ongoing education and outreach is needed for these types of concerns.
