**NOTICE OF HEARING TO THOSE WHO REQUESTED A HEARING**

**Proposed Amendments to *Minnesota Rules*, Chapters 7050 and 7052, relating to Tiered Aquatic Life Uses and Modification of Class 2 Beneficial Use Designations; Revisor's ID Number: RD4237**

**To persons who requested a hearing.** In accordance with Minnesota Statutes, section 14.25, subdivision 1, the Minnesota Pollution Control Agency (MPCA) is sending this notice to all persons who requested a hearing.

**There will be a hearing.** In the December 19, 2016, *State Register*, on pages 659 to 762, the MPCA published a Notice of Intent to Adopt Rules relating to Tiered Aquatic Life Uses and Modification of Class 2 Beneficial Use Designations, together with the proposed amendments. The Notice stated that the MPCA would hold a public hearing on the proposed rules if 25 or more persons submitted written requests. During the comment period, which ended at 4:30 p.m. on February 2, 2017, the MPCA received a sufficient number of requests for a hearing. Therefore, as stated in the *State Register*, the public hearing will be conducted in Room 100 of the MPCA St. Paul Office, 520 Lafayette Rd. N., St. Paul, MN 55155, starting at 3:30 p.m. on Thursday, February 16, 2017. To enable the public to participate throughout the state, the public hearing will also be held via video conference at the following MPCA Regional Offices:

- MPCA Detroit Lakes Office, 714 Lake Ave., Suite 220, Detroit Lakes, MN 56501
- MPCA Duluth Office, 525 Lake Ave. S., Suite 400, Duluth, MN 55802
- MPCA Marshall Regional Office, 504 Fairgrounds Rd., Suite 200, Marshall, MN 56258

The hearing will continue until all parties are heard or until the Administrative Law Judge adjourns the hearing.
