For those dental offices in the Twin Cities metropolitan area, contact Metropolitan Council Environmental Services directly to learn what to do, and how to comply with the U.S. Environmental Protection Agency (EPA) Dental Rule. **Do not submit** the Minnesota Pollution Control Agency (MPCA) *Dental compliance form* (wq-wwtp7-49a) if your office is in the Twin Cities (see the list of Twin Cities communities below).

For dental offices located **outside** the Twin Cities metropolitan area, the *Dental compliance form* needs to be submitted to the Control Authority for the community where the dental office is located. In Minnesota, some of the local publicly-owned treatment works (POTW) have delegated authority to oversee the Dental Rule. The communities and the dental contacts are found within this document, and the *Dental compliance form* will be submitted directly to the local POTW. Dental offices in communities not listed below will submit their *Dental compliance form* to the MPCA.
